4	Ad films	Promotional content entries in this medium are videos produced and created and launched first on a digital platform
5	Branded Content	Entries in this include advertising techniques used by brands to subtly or directly promote their products through appearances in films or film related media promotion on the content created and launched first on a digital platform such as product placement
6	Viral	Video content created and launched first on a digital platform with the most number of views and shares

- The Award categories may be changed / modified / split / merged / increased or cancelled by the Awards Management based on the number of entries received in each category, and the quality of the entries
- In the event that there are no Participants in a category are found to be worthy of inclusion, then the Award category may be cancelled. The jury may decide to add nominees in the category to maintain high standards of participation. The decision of the jury in this regard will be final. The Awards management will not entertain any queries in this regard

Eligibility Criteria for the Awards

- The content must have been initially created and released or exploited via the Internet (i.e., first public or private exhibition occurred via a video sharing site or unique URL) between January 1, 2018 to December 31, 2018
- Only the productions released from between January 1, 2018 to December 31, 2018 onwards will be considered
- The video sharing site or unique URL should have been created for public viewing and not for purpose of the award
- Participants should be Indian registered entities or foreign entities with a registered presence in India. Appropriate documentation will be furnished for authentication if requested
- Organizations applying for the Award must have completed at least 2 years of operations in India as on December 31, 2018. Appropriate documentation will be furnished for authentication if requested. For 'Digital Content Startup of the year' category the organization should be registered for at least 1 year as on December 31, 2018
- An individual participating in the Award must have completed 18 years of age as on December 31, 2018. Appropriate documentation will be furnished for authentication if requested
- Eligible content doesn't need to have been produced during the eligibility period, but has to be launched on a digital platform during the eligibility period which is January 1, 2018 to December 31, 2018
- Content which was initially premiered and/or first released, distributed, or exhibited in any other media, whether before, during, or after the eligibility period, is not eligible to apply
- The content not eligible for consideration, whether or not they were created for a digital platform are trailers, preview, episodes of established shows previously broadcasted on other media, commercials, feature films launched on other media etc.
- To be eligible for the Performance based categories, the individual(s) must have performed in an eligible program
- The participant should not be a winner of the Award in the previous editions with the same winning entry
- Each category may be awarded three winners. This is subject to the jury evaluation
- To be eligible for an Award; the organization, company, or other entity, must have produced (or caused the production of) and otherwise own and/or control an eligible content

- Content will be considered in the form that they appear online during the eligibility period and must remain posted online and available for public review at a specified URL or Web page during the Review Period (From January 1, 2019 to December 31, 2019)
- Programs that contain obscene or pornographic material, propagate “hate” messages, make defamatory statements, or which are otherwise offensive are not eligible to participate
- Fameposter Career Services Private Limited and its affiliates, subsidiaries and group companies are not allowed to participate in the Awards. Employees and immediate family members of sponsors and partners of the awards are not allowed to participate in the Awards
- The final eligibility of Participants will be subject to the discretion and approval of the Awards Management and/or the Jury
- A participating organization can send entries in more than one award category or apply more than once in the same category provided a separate application form to be filled
- Employees and immediate family members of the award management, sponsors and partners of the awards are not allowed to participate in the Awards
- The final eligibility of the Participant will be subject to the discretion and approval of the Awards Management and Jury

NOTE –

- The jury may modify the eligibility criteria from time to time with retrospective effect
- The jury holds the right to disqualify any application which does not meet the eligibility criteria without assigning any reason whatsoever

Timelines

- Efforts will be made to adhere to the defined timelines. However, the defined timelines are subject to change based on circumstances.
- Awards Management and its sub-contractors shall not be held accountable / liable for any disruptions / stoppages / interruptions or cancellation of the Awards or its ceremony or any part of its processes or public voting on account of any factors beyond its control

Call for entries

- The call for entries for the Awards will be announced in one or more media platforms and / or by direct communication with potential Participants, and that shall be construed to be adequate notice for call for entries
- If, multiple partners apply for the category, then they should agree amongst themselves who would be the rightful owner of the content. The Award’s management or any of its partners will not be involved in deciding the same
- Entries will be accepted in English language only. In case of regional language subtitles / translation needs to be included
- In case if Participant fails to submit the required documentation, they may be disqualified from participation
- The Jury has the right to reclassify application forms from one category to another or reject and application form, at its discretion. This is not contestable in any manner

Participant can apply for the Awards by:

- No hard copy will be accepted
- Participation in the Awards in any manner will be construed as an acceptance to the terms and conditions stated herein

- Last date for receiving completed application forms is 18:00 hrs. on 31st December 2018.
- Receipt of Application Forms after last date of receipt specified may be permitted only at the discretion of the Awards Management
- Awards Management will not be responsible if the entry submitted is damaged / lost due to lack or lapse in any communication on account of internet failure
- All mandatory questions (symbolized by *) must be answered. Incomplete entries with incomplete sections may not be considered.
- Participation in the Awards in any manner will be construed as an acceptance to the Terms and conditions stated herein

Appropriate documentation will be furnished for authentication if requested by the awards management been included within 3 working days

- Organization Incorporation date on company letterhead
- Launch date of content launched on company letterhead
- Client approval letter to use content, if applicable
- Age proof for individuals in form of license, passport, birth certificates etc.

Completeness of Entries/ Disqualification

- All mandatory fields of the entry need to be complete in all respects; else it may be disqualified from participation
- Supporting documents such as photos, videos, screenshots, photographs, references, project plan, demo and other material can be submitted for each entry on a non-returnable basis
- Disqualification of entries is at the sole discretion of the Jury, on a case by case basis
- If at any time, during the Awards process or post the Awards, any information provided by any Participant is found to be incorrect in any manner, then the Participant will be disqualified from the Awards

Award

- In case an Award is unclaimed by the winner due to any reason the same will result in forfeiture of the Award by such Winner and Fameposter Career Services Private Limited shall not entertain any claims in this regard thereafter
- Award is not transferable or assignable and shall not be assigned to any other person. There is no cash substitution, cash redemption or cash value in lieu of the respective Award
